Under the above circumstance the Karnataka State Fire & Emergency Services Department is issuing the "Fire Safety Compliance Report" to "M/s. *In case the fire prevention and firefighting measures installed as per the recommendation of the department are not maintained in good working condition, if the evacuation measures are not properly followed and if any additional construction work is taken up in the building/premises, the Fire Safety Compliance Report deemed to be cancelled and necessary legal action will be initiated against the developer/management/tenant and also separate NOC has to be obtained from the department for the storage of chemicals, solvents, Petroleum products, LPG etc. in the premises/building.*
